9. You must show up at the Home InStyle 2026 and complete a buyer survey when collecting the Travel Reimbursement Voucher at the "Buying Mission Service Counter". The person collecting the Voucher and the stamps must be the same person applying for this programme.

The HKTDC reserves the right to reject any reimbursement requests should there be any informational discrepancies on the passport, landing slip, boarding pass and e-ticket receipt.
